Sale of First Shipment

We are pleased to announce the sale of our first shipment of ore from the Ant Hill trial mining project jointly owned via the MESA Mining Joint Venture with HiTec Energy Ltd.

Alan Scott of HiTec:

“As a direct consequence of improved market prices and terms being offered for manganese ores, HiTec has contracted for the sale of 30,000t (±10%) of the ore currently stockpiled at the Ant Hill mine. The ore sale contract provides working capital support to the seller and trucking of the first cargo to HiTec's Boodarie lay-down area in Port Hedland is scheduled to commence in August to meet a September ship loading schedule. HiTec has contracted this sale as agent for the Mesa Mining Joint Venture participants, namely itself and Auvex Resources Limited (Auvex), each of which hold a 50% interest in the ore sold.”
